There are several significant rule changes, so be sure to review contestant rules as well as your event rules. After the next board meeting on February 7th, I will post the new rule book on the website.

Contestant changes: (this are only a few, so please review your 2012 Rulebook)

1. Dress code for ALL contestants and helpers is as follows:

Long sleeve button or snap up shirts with collars and cuffs (sleeves rolled down tails tucked in), hats and boots must be worn in the arena by ALL contestants 1 hour before, during and after the performance. The confines of the arena compound (bucking chutes, announcer stand, timed event boxes, catch pens) are considered part of the rodeo arena. Failure to do so will result in an automatic fine. The 1st offense will be a fine of \$50. For each offense thereafter, the fine will be raised an additional \$50. This will include and affect any helper.

2. Memberships will now cost \$5 more if you would like a newsletter mailed to your address. For members who would like to receive newsletters by email, the cost will be the same as last year.

3. Rookie applications must be secured 60 days before the 1<sup>st</sup> date of the Finals. Current year points will count.

4. Rough stock riders may enter their event 2 times. Points for standings will only count for highest place.

5. Rough stock riders who enter 6 ARA 1<sup>st</sup> rodeos, but do not win enough or any money to qualify for finals, will be invited to compete in the ARA finals as a contestant. Invitation will be based on number of ARA 1st rodeos entered, with 6 being the minimum.
